Our mission is to support credit union success, and the CMG Memorial Foundation scholarship program is one of the many ways we accomplish this. The CMG Memorial Foundation was established in honor of the late Christine M. Gross, an Alloya friend and colleague. The Foundation provides a number of scholarships throughout the year for Alloya members with less than \$100 million in assets. Small-asset-sized credit unions had a special place in Christine's heart, and Alloya carries on her memory by helping these credit unions take advantage of opportunities they might otherwise forego due to a limited budget.

### SCHOLARSHIP DETAILS

Scholarship awards for designated events and activities will cover participation costs – including transportation, lodging and registration fees. Please note that awards work on a reimbursement basis. Recipients will need to register and pay for costs associated with attending the event and submit receipts to Alloya at the conclusion of the event.

Awards are granted based on an application process where the Foundation board will review all qualified submissions approximately one month prior to the event date. In order for board members to have adequate information to review, all applicants are asked to provide a *full description* on the application of what he/she hopes to gain from participating in the event.

Submission deadlines for events in which a scholarship will be offered will be announced via email. These deadlines will also be posted on Alloya's website at [www.alloyacorp.org/cm-g-memorial-scholarship/](http://www.alloyacorp.org/cm-g-memorial-scholarship/). Interested members will need to complete this application and return it to Alloya by the indicated submission deadline. Award recipients, as well as applicants who were not selected, will be notified before the registration deadline for the event.
