## Alloya Awards \$100,000 to Charity in Honor of Tenth Anniversary

Naperville, Ill. (October 26, 2021) – In honor of its tenth anniversary on October 24, Alloya Corporate Federal Credit Union launched a "10 for 10 for 10" program in which the corporate donated \$10,000 to 10 charities over 10 business days. The charities were chosen through a nomination and selection process driven by Alloya's credit union membership. In total, Alloya received 101 nominations over the 10-day nomination period.

"We were thrilled to see such strong interest in our '10 for 10 for 10' program," commented Todd Adams, chief executive officer of Alloya. "We wanted to give back to our members and their communities in a meaningful way in honor of Alloya's anniversary, and members' engagement with the program allowed us to do that."
